



Dear friend,

As you may have seen in the newsletter CNI Network was unsuccessful in its bid for Lottery Funding. Completing the two long application forms took 12 months from start to finish with a large amount of time and research spent on this.

The trustees of CNI met at the conference to look at how we move forward. Realistically we need a minimum income of £4000 a month in order to pay a realistic salary and to cover expenses and expansion of our work. A secure income would enable us to do more including offering the accredited training package to local projects, helping local projects with the alcohol and safety education pack, purchasing flip-flops centrally, etc.

**If every one of our 122 projects could donate just around £20 a month we would be able to commit to new and existing work safe in the knowledge we are able to pay a salary and not have to spend a huge amount of time filling out grant application forms.** We also welcome support from churches, individuals, etc.

We hope that we have supported projects in a variety of ways to make this money back - for example: the insurance policies we have in place have seen local projects save between £300 and £500 per annum based on the next available insurance policy; the 'dudes with wings' product range can help you raise extra money within local churches and at talks; and the 'Who are the Street Angels' comic book which can be offered at talks you carry out for a donation.

The work and role of CNI Network is still needed, and recently we have seen increased:

- media interest (including a potential Songs of Praise feature next year);
- work with partner agencies such as CALLA, Wash My Pink Jumper and POP Campaign;
- opportunities for work at music festivals, in clubs venues through Club Angels and at European clubbing resorts;
- national and regional networking events;
- the need for a 'one stop place' for information on what is happening within the night-time economy.

We thank those projects who already support us and hope that together we can rise to the challenge - if we all give a little the difference will be made.
